Sub: Common Entrance Test 2014 – mandatory eligibility criterion for admissions to IMU courses – switch-over to Computer-based CET from 2014 onwards – reg.

Ref: 1. Minutes of the meeting of the Vice Chancellor, IMU with all Affiliated Institutes held on 14.3.2014.
2. Minutes of the meeting of the Vice Chancellor, IMU with all Campus Directors of IMU held on 15.3.2014.

Admissions to courses conducted in IMU Campuses and Affiliated Institutes are done through an All-India Common Entrance Test (CET) usually held in the month of June every year.

2) Based on the recommendations made in the two meetings cited above, IMU has decided to switch over to a Computer-based CET from 2014 onwards with the entire spectrum of activities - from the registration of applications to the publication of results - being done online. M/s Tata Consultancy Services (TCS) has been selected as the Service Provider. **This year's CET will be held between 2 pm and 5 pm on Saturday, 14th June 2014** in 34 cities all over India.

3) Advertisements were published on 18th and 25th April 2014 in leading newspapers in Hindi, English and vernacular languages besides Employment News and Rozgar Samachar. **The last date for the online registration of applications is 20th May 2014.** To supplement this effort, IMU Campus Directors and Principals/Secretaries of Affiliated Institutes are requested to give wide publicity through social media, schools and coaching institutes so that the maximum number of candidates apply for the CET 2014.

4) Kind attention of all Affiliated Institutes is drawn to Section 5, sub-sections (xxvii) and (xxxiii) of the Indian Maritime University Act, 2008 read with Chapter VII of Ordinances Governing Academic Matters as published in the Gazette of India Extraordinary on 12th May 2009 according to which no student shall be eligible for admission to any UG or PG course in the IMU unless he has passed the exam or exams prescribed by the University. Passing the CET conducted by the IMU is one of the essential eligibility criteria for admission, along with criteria relating to age, marks in Plus 2 exams, medical fitness, etc., as set out in IMU's Academic Brochure 2014. **No Affiliated Institute shall, therefore, make any admissions of students (including sponsored/management candidates) unless they have qualified in the CET 2014.** It may be noted that if any candidate is admitted without qualifying in CET 2014, he will not be given admission registration number nor will he be allowed to appear in any of the scheduled examinations of IMU.

5) This circular issues with the approval of the competent authority. With regard to Counselling, a separate circular will be issued.
