Sub: Procedure to be adopted during Counselling for Admissions into Affililiated institutes.

The provisional results of IMU CET 2014 were published in the IMU website on 18-06-2014. 6298 candidates have qualified in the IMU Counselling for under graduate courses (i.e)

1.B.Tech (ME)

2.B.Tech (NA&OE)

3.B.Sc (NS)

4.B.Sc(MS)

5.B.Sc(SBR)

6.D.N.S.

The following points should be borne in mind while doing admission to DNS leading to B.Sc., (Nautical Science).

- The admissions for DNS programme for August 2014 batch are based on IMU guidelines and Director General of Shipping directions.
- Therefore all affiliated institutions would be required to have made the necessary tie-up for onboard training for their candidates with Ship

owning companies or Ship Managing companies. The institution should give an undertaking to this effect for admission of sponsored candidates.

- 3. The list of sponsored candidates should be forwarded to IMU on or before 4th July 2014 in the format prescribed. The sponsored candidates should be qualified in the CET merit list of IMU which was hosted in IMU website. The proof for allotting the sponsored seats should be attached.(i.e., The Ship Owning Companies or Ship Management Agencies RPSL sponsored letter should be enclosed)
- 4. If the number of seats for which tie-ups for onboard training have been made exceeds the number of CET-passed sponsored candidates available with the institute, the institute may either surrender these 'extra' seats to IMU's counselling (along with proof of tie-ups for onboard training) or continue with their efforts to find alternative sponsored candidates who have passed the CET. IMU will not take 'surrendered seats' for counselling for DNS unless proof of tie-ups for these seats for onboard training has been furnished.

In this regard the affiliated institutions are requested to submit the two enclosed formats, Format A and B and an undertaking in Rs.100/- (Non judicial stamp paper) (format enclosed) while surrendering DNS seats to IMU counselling.

If any candidate is admitted in other than the above mode, he will not be given admission Registration number nor will he be allowed to appear in any of the scheduled examinations of IMU.
