**NOTIFICATION**

**SPOT COUNSELLING-for B.Tech(NAOE) only**

1. It is hereby informed that 02 (two) vacant seats of B.Tech-NAOE created due to the withdrawal of candidates will be filled on **14.09.2022** by **SPOT COUNSELLING**, on rank-merit basis. All candidates as follows (including those who missed earlier) who have not confirmed their admissions to IMU can apply:

**a) Fresh Candidates:**

All CET22 RANKED candidates who have not registered earlier for counselling and are desirous of taking admissions to IMU Campuses can walk-in with 4 separate Demand Drafts(DDs) of Rs 10,000(Counselling Fees); Rs 25,000(Programme Fees); Rs 20,000(Caution Deposit) & Rs 1Lakh (Semester Fees).

**b) Candidates who registered for counselling but their admission not confirmed due to any reason:**

All candidates who have registered earlier by paying Rs.10,000 need to walk-in with three DDs of Rs 20,000; Rs 25000 & Rs 1 Lakh.

**c) Candidates who paid counselling & programme fees but their admission not confirmed due to any reason**

All candidates who have already paid Rs. 10,000 counselling fees and Programme fees may come with two DDs of Rs 25000 & Rs 1 Lakh.

**d) Rejected candidates:**

The candidates who were rejected during Certificates Verification and could not secure a seat can walk-in for spot counselling. However, they need to rectify the defects pointed out during Certificates Verification and appear for spot

counselling. Candidates who appeared for improvement exams and now have 60% PCM marks can also apply.

2. The candidates who have who have confirmed their admission in any IMU Campus are not eligible for SPOT COUNSELLING.
3. The candidates have to mandatorily report in person preferably at the IMU Vizag campus or at any IMU Campus for Certificates Verification & Spot Counselling at 10 AM.
4. Verification will be carried out from 10AM-12PM on 12.09.2022. At 1230 PM the SPOT COUNSELLING will be conducted for verified candidates.
5. Please bring the following:
  - i. Proof of Age – Birth Certificate / 10th Std / SSC or equivalent Mark sheet
  - ii. 12th / Higher Secondary School or equivalent Mark sheet
  - iii. Community Certificate (Only for SC, ST, OBC-NCL / GEN – EWS)
  - iv. Printed Copy of IMU's CET Rank Certificate
  - v. 2 Copies of Passport size Photographs
  - vi. Aadhaar Card
  - vii. UG Mark sheets / Certificate (if applicable)
  - viii. Medical Fitness Certificate from any Registered Medical Practitioner (RMP).
  - ix. Demand Drafts:
    - a. DD of Rs 10,000 (Counselling Fees) if not paid earlier.
    - b. DD of Rs 20,000 (Caution Deposit)
    - c. DD of Rs 25,000 (Programme Fee) (Candidates who had paid Programme Fee earlier and missed Certificates Verification or got rejected in Certificates Verification need not pay Programme Fee again).
    - d. DD of Rs 1 Lakh (Semester Fee)
6. Before confirming the seat, the candidate has to hand over the DDs to the verifying officer. Once DDs are handed over, the seat can be confirmed & the confirmation letter can be downloaded. **Once the**

**confirmation of seat is completed and the confirmation letter is downloaded, no refund is permitted.**

7. The candidates allotted seat in spot counselling have to join immediately from the same day, hence the candidates are advised to come with preparation accordingly.

**8. Please note that the allocation is for 2 seats of B.Tech(NAOE) only. Hence candidates interested to pursue B.Tech(NAOE) only should participate.**
