It is proposed to fill the seats available for the B Tech (Naval Architecture & Ocean Engineering) program being conducted at Visakhapatnam **campus for Academic Year 2018-2019 through lateral entry scheme (admission into 2nd year).**

The duration will be three academic years consisting of six semesters of course work. For details of the program and fees please refer to the academic brochure for 2018-2019 available at www.imu.edu.in. www.imuv.edu.in,

Indian Maritime University invites applications from eligible candidates fulfilling the educational and other eligibility criteria for the U G program at its Visakhapatnam campus through the lateral entry scheme.

1. Age Limit:

- i) Minimum age 18 years
- ii) Maximum age 26 years

Note: a) For Scheduled Caste (SC) & Schedule Tribe candidates (ST) candidates maximum age relaxation is for five (5) years.

2. Educational Qualifications

- a. A Diploma in Ship Building Engineering from Institute of Ship Building Technology (ISBT), Goa with at least 60% marks overall and should have completed the diploma within the stipulated period 4 years.

Or

- b. A Diploma in Mechanical / Civil Engineering / Marine Engineering from any institute approved by AICTE with at least 60% marks overall and should have completed the diploma within the stipulated period of 3 years.

Or

- c. 3-year Diploma in Naval Architecture and Offshore Engineering from the AMET University, Chennai with at least 60% marks overall and should have completed the diploma within the stipulated period of 3 years.

3. **No. of seats vacant:** Total No of seats vacant are 5 and admissions will be made in the order of merit based on aggregate percentage of marks in their respective diploma.

A. Interested candidates should download the application form from www.imuv.edu.in submit the same along with self-attested copies of certificates and mark sheets by post so as to reach the following address on or before 1st July 2018.

The applications received will be scrutinised category wise based on the age and qualifying educational criterion and shortlisted based on merit only. The list of shortlisted and waitlist candidates will be put up in the website www.imuv.edu.in . The shortlisted candidates will also be intimated by e-mail.

B. The shortlisted candidates will be required to report at IMU, Visakhapatnam Campus for verification of certificates & counselling on **10th July 2018 between 1000 hrs and 1600 hrs**. The following certificates should be produced in original at the time of counselling.

- I. SSC / 10th Standard Mar sheet (for proof of date of birth)
- II. Provisional Certificate / Degree or Diploma Certificate as applicable
- III. Course Completion Certificate (if provisional certificate is not issued)
- IV. Statement of Marks of all Semester / academic years.

C. After verification of certificates, the candidate will be issued the admission letter.

D. IMU reserves the right to allocate any leftover seats in any category to waitlisted candidates in that category or to any other remaining categories.

E. The Selected candidates will have to report at IMU, Visakhapatnam Campus and register for the 3rd semester on **1st August, 2018**

5. **Fee Particulars:**

A. **An application Fee for Rs.1000** for General candidates and **Rs.700** for schedule Caste /Scheduled Tribe candidates to be paid along with the submission of application in the form of Demand draft payable at Visakhapatnam in favour of Indian Maritime University, Visakhapatnam campus.

B. Upon confirmation of admission, the candidates are instructed to pay the following fee at the time of reporting to IMU, Visakhapatnam campus for formal registration on 1st August 2018.

- I. A Counselling fee of **Rs.10,000/-** through a Demand Draft in favour of Indian Maritime University, payable at Visakhapatnam.

- II. **Rs.25,000/-** towards Programme Fee through Demand Draft in favour of Indian Maritime University, payable at Chennai.
- III. The Semester fee of **Rs.1,00,000/-** should be paid at the campus for 3rd semester fee on the day of registration through a Demand Draft in favour of Indian Maritime University, payable at Visakhapatnam.
- IV. A fee of **Rs.20,000/-** should be paid at the campus as caution deposit (refundable) through a Demand Draft in favour of Indian Maritime University, payable at Visakhapatnam.
- C. Balance fee for 2nd year **Rs.1,00,000/-** will be paid in the month of January 2019.
