- Colour: Black

8. Sealed quotations will be opened & evaluated & purchase order shall be placed to the bidder who has quoted the lowest rate without any condition.
9. The submission of tender shall be taken as the explicit acceptance of all terms and conditions stipulated herein.
10. No request for change in rates once quoted / accepted will be entertained for any reason during the currency of the contract. The rates of the contract shall be firm, fixed and final and binding on both the parties.


