Sub: Regulations for admission of Sponsored Candidates from Industry for PG programmes - reg.

Ref: Executive Council resolution vide agenda EC 2025-82-07 dated 11.02.2025.



1. The Executive Council in its 82nd meeting vide agenda no EC 2025-82-07 resolved to approve the following regulations for admission of Sponsored Candidates from Industry for PG programmes from the Academic Year 2025-26:

- a. Candidate must be an Indian National.
- b. Maximum age Limit preferably below 50 years
- c. A candidate working in an academic institution/PSU/Govt. R&D organizations/Govt. recognized private R&D organizations/industry, is considered as a potential candidate for sponsorship.
- d. General eligibility criteria and qualifying degree for the sponsored candidates remain the same as the regular candidates in the respective programs.
- e. Candidates must be sponsored by his/her employer and must have been in employment with the sponsoring organization for at least 2 years at the time of admission.
- f. Two years of service experience must have been gained by the candidate after acquiring requisite qualifying degree.
- g. There is no entrance examination for sponsored candidates and admission for sponsored seats will be based on merit of UG Marks.
- h. Sponsored students will not be eligible for any scholarship, prize etc.
- i. Maximum of Five (05) super numerary seats each in all the post graduate programmes for sponsored candidates.
- j. No self-sponsored candidate will be admitted
- k. There is no separate batch for sponsored candidates. They have to attend regular classes along with non-sponsored candidates.
- l. The sponsored candidates will be admitted into full time PG programmes only.
- m. The Ordinances for minimum attendance requirement, fee structure, break-in-studies and other academic and examination related ordinances promulgated from time to time are also applicable to sponsored candidates.
- n. Mode of receiving application form (in the prescribed format) is through email.

- o. Admission will be on First Come First Serve (FCFS) basis, to be determined by the date stamp of the email received.
- p. Fees will be paid by the Employee or by the Employer at the beginning of each semester as per the provisions of the Ordinances.
- q. Application should be forwarded by the Employer along with sponsorship letter on their letter head or the employee himself along with the Sponsorship letter issued by the employer on their letter head.
